

How to Read Your Water Bill


Customer Portion

- 1 Meter size, service address and customer of record.
- 2 Reading dates, meter readings, total days and consumption billed.
- 3 Date your account was billed and your account number.
- 4 Previous bill, payments received prior to billing and balance brought forward.
- 5 Current charges including basic service and usage in excess of the basic service allowance. These amounts equal the water charge. The current bill is the total of the water charge plus or minus any additional credits, fees, adjustments, etc.
- 6 The total amount due upon receipt is the current bill plus or minus any previous balance brought forward.
- 7 Important messages concerning your account, water service and the number to call for inquiries and emergencies.

Payment Stub

- 8 Bill date, account number, payment due date and total amount now due. Enter the amount you are enclosing and return this portion with your payment
