WHEREAS, the Board of Directors of the Water Authority of Western Nassau County (hereinafter "Water Authority") has received a memorandum from Janice Varley, Director of Human Resources of the Water Authority recommending that the Water Authority approve the automatic renewal of medical insurance coverage with the New York State Health Insurance Plan (NYSHIP), effective January 1, 2014 through December 31, 2014 for Water Authority employees;

- **BE IT RESOLVED,** that the Board of Directors of the Water Authority hereby approves the renewal of medical insurance coverage with NYSHIP, effective January 1, 2014 through December 31, 2014 for Water Authority employees; and
- **BE IT FURTHER RESOLVED,** that Tier 1 employees of the Water Authority shall contribute ten (10%) percent to the cost of the premium for the NYSHIP plan; and
- BE IT FURTHER RESOLVED, that Tier 2 employees of the Water Authority shall contribute fifteen (15%) percent to the cost of the premium for the NYSHIP plan; and
- **BE IT FURTHER RESOLVED,** that Tier 1 retirees of the Water Authority shall contribute the same percentage to the cost of coverage as approved by the NYSHIP resolution number 045/09/10 for the NYSHIP plan; and
- **BE IT FURTHER RESOLVED,** that Tier 2 retirees of the Water Authority shall contribute the same percentage to the cost of coverage as approved by the Tier 2 resolution number 015/11/12 for the NYSHIP plan; and
- **BE IT FURTHER RESOLVED**, that the Board of Directors of the Water Authority authorizes the elimination of all other medical insurance plans currently offered.

WHEREAS, the Water Authority is rehabilitating the elevated water tank known as "Tank No. 19" and requires an engineer to prepare the plans and specifications for the work, perform construction administration and construction inspection throughout the project; and

WHEREAS, Holzmacher, McLendon & Murrell, P.C. (hereinafter "H2M") submitted a proposal to perform said engineering services for the sum of \$226,500.00; and

WHEREAS, a written recommendation was forwarded to the Board of Directors by Robert Swartz recommending that the Water Authority engage the services of H2M to prepare the plans and specifications for the work, perform construction administration and construction inspection throughout the project in accordance with its submitted proposal;

NOW THEREFORE, upon motion of D. Longobardi, seconded by G. Bakich,

**BE IT RESOLVED,** that the proposal of H2M in the amount of \$226,500.00 to prepare the plans and specifications for the work, perform construction administration and construction inspection throughout the project is hereby accepted; and be it

**FURTHER RESOLVED,** that the Chairman of the Water Authority be and hereby is authorized to execute a contract, in a form acceptable to Counsel, with H2M for said purposes.
