WHEREAS, upon review of such bid proposals by the Water Authority, a written recommendation was sent to the Board of Directors by Robert J. Lucas, P.E. of H2M Architects and Engineers, the Water Authority's consulting engineer, stating that JPI Painting, Inc. was the lowest responsible bidder meeting the bid specifications and recommending award of the contract thereto; and

WHEREAS, the Board of Directors of the Water Authority has determined that JPI Painting, Inc. is the lowest responsible bidder meeting the bid specifications;

NOW THEREFORE, upon motion of D. Longobardi, seconded by S. Powderly,

BE IT RESOLVED, that the bid proposal of JPI Painting, Inc. in accordance with its alternate bid in the amount of \$2,826,250.00 be and the same is hereby accepted; and

BE IT FURTHER RESOLVED, that the Chairman of the Water Authority be and hereby is authorized to execute a contract with JPI Painting, Inc. to perform the tank rehabilitation/painting to the Water Authority elevated storage tank known as Tank No. 19 in accordance with its requirements, for the prices specified in said bid proposal and in accordance with the bid specifications for said contract.

Open for discussion and roll call vote. M. Wohlgemuth asked where the money is coming from for this project. Mr. Tierney noted it has been provided for in the capital fund.
