WHEREAS, the Board of Directors of the Water Authority, on behalf of the Water Authority has determined that it would be in the best interests of the Water Authority to retain Environmental Capital, LLC to provide financial advisory services in connection with the aforementioned bond issuance of the Water Authority in accordance with its proposal dated October 1, 2014, in the fixed amount of \$40,000.00 with an additional fixed fee of \$20,000.00 in the event the Water Authority elects to retire the remaining balance of the 2005 bond issuance;

#### Resolution #043/14/15: Retention of Bond Counsel

WHEREAS, the Board of Directors has determined that it is necessary to engage the services of Nixon Peabody, LLP to represent the Water Authority in connection with legal issues related to the new bond issue and retirement of the existing bonds in accordance with its proposal dated September 30, 2014 at the hourly rates described therein not to exceed \$85,000 in total legal fees for a new bond issuance or not to exceed \$110,000 in total legal fees for a new bond issuance and retirement of the previously issued bonds;

**BE IT RESOLVED**, that the Board of Directors of the Water Authority hereby engages the services of Nixon Peabody, LLP as bond counsel for all legal services with respect to a new bond issuance and the possible retirement of the outstanding 2005 bond issuance, in accordance with its proposal dated September 30, 2014 at the hourly rates described therein not to exceed \$85,000 in total legal fees for a new bond issuance or not to exceed \$110,000 in total legal fees for a new bond issuance and retirement of the previously issued bonds; and
