BE IT FURTHER RESOLVED, that the Chairman of the Water Authority be and hereby is authorized to execute a one year contract with two successive one year options, to be exercised in the sole exclusive discretion of the Water Authority, with Saf-Gard Safety Shoe Company to supply footwear to the Water Authority, in accordance with its requirements, for the prices specified in said bid proposal and in accordance with the bid specifications for said contract.

BE IT RESOLVED, that the bid proposal of Fastenal Company be and the same is hereby accepted and the irregularity of failing to submit a certified check for the bid deposit at the time of the bid opening is hereby waived, the contractor having replaced the corporate check with a certified check prior to the award of the contract, and

BE IT FURTHER RESOLVED, that the Chairman the Water Authority be and hereby is authorized to execute a two year contract with Fastenal Company to supply tools to the Water Authority, in accordance with its requirements, for the prices specified in said bid proposal and in accordance with the bid specifications for said contract.

WHEREAS, the proposals are less than the threshold required for a sealed public bid as required by the General Municipal Law; and

WHEREAS, the Board of Directors has determined that it is in the best interests of the Water Authority to contract with Layne Christensen Corp. to perform the test;
