WHEREAS, the Board of Directors has received a memorandum from Michael J. Tierney of the Water Authority recommending approval of the proposal from H2M Water in the sum of \$9,800.00 to perform the requested inspection and report; and

WHEREAS, Board of Directors of the Water Authority, on behalf of the Water Authority has determined that it would be in the best interests of the Water Authority to approve the proposal of H2M Water to conduct the inspection and prepare an engineering report for the Water Authority;

Resolution #073/15/16 - Acknowledgement of Withdrawal of Union Representation and Salary Adjustment

WHEREAS, Local 175, United Plant and Production Workers Union (hereinafter "Union") was certified as the exclusive bargaining representative of the employees of the Water Authority of Western Nassau County (hereinafter "Water Authority") in the transmission and distribution department in 2013; and

WHEREAS, the Water Authority provided the employees of the Water Authority, excluding those represented by the Union with a 2.5% raise effective June 1, 2014 and a 2.25% raise effective June 1, 2015; and

WHEREAS, the Water Authority and the Union have not reached an agreement regarding the terms of a first collective bargaining agreement between the Water Authority and the union; and

WHEREAS, the Water Authority has received correspondence from the Union indicating that they are voluntarily withdrawing their representation of the employees in the transmission and distribution department by mutual agreement; and

WHEREAS, the Water Authority is desirous of providing the employees in the transmission and distribution department the same raises provided to the Water Authority employees not represented by the Union retroactively to June 1, 2014, including those employees that may have left the employ of the Water Authority and also to provide an increase in the standby pay for the employees in the transmission and distribution department from \$150.00 per week to \$250.00 per week;

Now therefore, upon motion of D. Longobardi, seconded by B. Brown,

BE IT RESOLVED, that the annual salaries for the employees of the Water Authority in the transmission and distribution department are hereby adjusted to reflect a 2.5% raise per annum effective June 1, 2014 and a 2.25% per annum increase, effective June 1, 2015, to be paid in accordance with the current payroll system, including retroactive pay to said employees including those that may have since left the employ of the Water Authority; and

BE IT FURTHER RESOLVED, that the compensation for the employees of the Water Authority in the transmission and distribution department for stand-by pay is hereby increased from \$150.00 per week to \$250.00 per week effective immediately; and

BE IT FURTHER RESOLVED, that the Board of Directors of the Water Authority y hereby authorizes notification of the Nassau County Department of Civil Service accordingly. Open for discussion and Roll call vote.
