The meeting was called to order at 7:35 PM by J. Ryan. The salute to the flag was led by M. Wohlgemuth.

Mr. Ryan immediately opened the meeting to Public Comment. T. VanBuskirk of Flowerview Gardens complained about noise from cutting pipe at 7:00 AM. Mr. Tierney stated these kinds of activities do not take place in this facility at all. Mr. Ryan assured Mr. VanBuskirk that this issue will be addressed with the Superintendent and staff.

- B. Machen of the Water Authority addressed his concerns regarding medical coverage to the Board of Directors. Mr. Machen requested that the Board address the concerns of staff regarding this matter.
- J. Tangredi of Stewart Manor addressed the Board regarding his concerns about hydrant rental rates and proposed price increases. Mr. Tierney noted that the Operating Plan for the new fiscal year is not yet complete, but any increase in hydrant rentals will be lower than the 15% that Mr. Tangredi heard.

A discussion took place between Mr. Tierney and C. Gorman regarding the process of inspection and repair of hydrants and a request from the Village of Stewart Manor requesting assistance in the maintenance of their hydrants.

Mr. Tangredi also asked about hydrant issues on the dead end streets in Stewart Manor. T. Mulzoff, B. Swartz and Mr. Gorman will meet with Mr. Tangredi to discuss these issues.
